- Ronin SA incorporates in 1995
- Ronin SA generates a strong brand name in the UK CP Training Industry in 2001
- Ronin Concepts is registered in 2004 in the UK
- Ronin Concepts is deregistered and reregistered twice between 2004 and 2006 (UK Companies House)
- Ronin SA trademarks the word "Ronin" specifically with respects to the CP Training Industry within the European Union, United Kingdom and South Africa in July 2007
- Ronin Concepts Security Elite incorporated in 2008 after the trademarks are in effect (UK Companies House)
- Ronin Concepts applies to trademark the name Ronin with respects to close protection and first aid training in February 2015
- Ronin SA notifies the British Trade Marks Registry of our intention to oppose the registration of this mark based on Ronin SA's prior registration of the mark in 2007.

Ronin SA has made repeated requests for Ronin Concepts and Ronin Concepts Security Elite to stop using its trademarked name which they have to date refused to do.

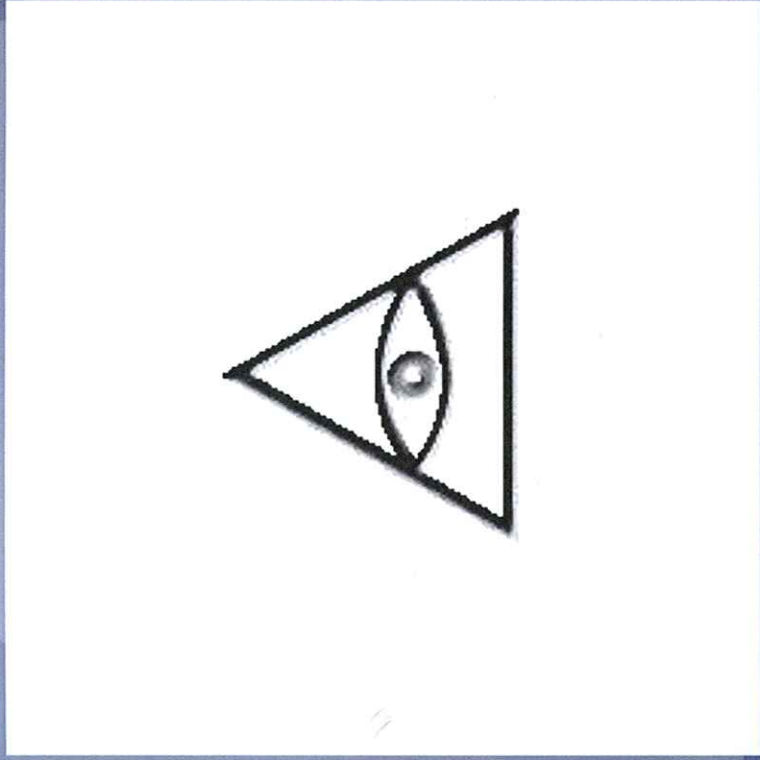

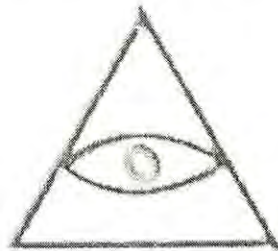
